



SARU AND ABSA COMPETITION TERMS AND CONDITIONS

ENTRY AND PARTICIPATION RULES

1 GENERAL ENTRY CONDITIONS

- 1.1 The competition starts at 12:00 on Monday, 1 September 2014 and closes at 17:00 pm on Wednesday 22 October 2014. No late entries will be accepted.
- 1.2 The competition is open to South African residents only
- 1.3 Entrants must be over the age of 16 years.
- 1.4 The following persons are excluded from this competition and may not participate –
 - 1.4.1 a director, member, partner, employee or agent of, or consultant to South African Rugby Union (“SARU”), Absa as Title Sponsor or any other person who directly or indirectly controls or is controlled by SARU and Absa;
 - 1.4.2 a supplier of goods or services in connection with this competition;
 - 1.4.3 the spouses, life partners, business partners or immediate family members of the parties referred to in 1.4.1 and 1.4.2;
