

Kaizer Chiefs “Best Seat” 2016 Competition

By participating in this competition, entrants agree to these Rules.

1. By entering into the **BEST SEAT 2016 COMPETITION**, entrants agree to the rules set out below.

5. The Competition will commence on **01 October 2016 and end on 16 February 2017**, both days inclusive. No entries received after midnight on 16 February 2017 will be considered.
6. To participate in the Competition, each participant must: send an SMS with the keyword “KCCouch” to the number 33044. (Cost R1.50 per SMS. Free minutes do not apply) The participant will then be successfully entered into the competition.
7. A random audited draw to determine the prize winner will be conducted on a date decided upon by the club at the Kaizer Chiefs offices in Naturena.
8. The prize winner will be notified telephonically on the number used to enter the competition.
