Betway Premiership 2025/2026 - Betway 'S 'Bonise and Win"

Competition Terms & Conditions

1. Competition Rules

1.1 The Betway Premiership Betway 'S"Bonise and Win" competition ("the Competition") starts

on 8 Aug 2025 at 00h00 and ends on 26 May 2026 at 23h59 both dates inclusive ("the

competition period"), with game/fixtures dates on the PSL website. Exact end date to be

included once fixtures are released.

1.2 The Betway 'S"Bonise" and Win competition will be taking place at all stadiums where

broadcast Betway Premiership fixtures will be played.

1.2.1 The Competition will take place as per the following details:

Fixture: All broadcast Betway Premiership fixtures

• Date: 9 August 2025 – 26 May 2026

• Venue: All stadium venues where broadcast fixtures will take place

1.3 At each of the Betway Premiership broadcast fixtures Betway will reward one (1) winner with

R10 000 or R20 000 if they are a Betway customer.

1.3.1 To qualify as an entrant, the participant/entrant must:

Purchase a valid match ticket for any broadcast Betway Premiership fixture

Be wearing home team regalia or colours

Must be 18 years or older

A natural citizen or permanent resident of South Arica

The winner will only ever be contacted in person at the stadium by an agency

representative.

1.4 Method of Entry:

The Betway S'bonise and Win mechanics are as follows:

1.4.1 An independent third party will select a fan (the specified fan") in the stands before

the start of the match.

- 1.4.2 An agency stadium representative will receive communication from the third party with an image of the specified fan and position in the stadium.
- 1.4.3 Once the specified fan is located then the agency stadium representative will communicate the following qualifying criteria to the specified fan, all of which must be met:
 - Verification that they are over the age of 18, proof required.
 - Verification of match day ticket
 - Willingness to be on camera
 - The specified fan must be sober minded until the end of the game and willing to move from their seat at any time during the game.
 - Confirm whether or not the specified fan is an active Betway customer.
- 1.4.4 If the specified fan confirms that they are an active Betway customer, the agency stadium representative will contact Betway call centre to confirm.
- 1.4.5 Once the specified fan provides meets the above-mentioned qualifying criteria and agrees to the terms and conditions contained herein, they will be declared the winner of the Competition.

1.5 The Betway 'S "Bonise and Win" prize is as follows:

1.5.1 R10 000 Cash prize or R20 000 if confirmed to be an active Betway customer.

1.6 Regional Fixtures:

- **14.** We may require you to provide us with such additional information and documentation as we may reasonably require in order to process, confirm and facilitate your acceptance and/or use of a prize. If you refuse to provide us with the requested information or documentation, you will forfeit the prize.

- 29. Betway is not obliged to award more than the defined prize.

30. The prize:

- **33.** For purposes hereof, "affiliate" means our partners, co promoters and sponsors of this competition, our subsidiaries, our and their subsidiaries and respective holding companies, the subsidiaries of their holding companies, and our and their directors, officers, employees, agents and representatives.

- **34.** These terms and conditions will be construed, interpreted, and enforced in accordance with the laws of contract and dispute resolution in the Republic of South Africa.
- **35.** Betway and the judges' decision on any matter concerning the competition and/or arising out of these terms and conditions is final and binding on you, and no correspondence will be entered into
